

## Privacy Policy

We respect your right to privacy and are committed to protecting your information. This Privacy and Cookie Policy sets out to define how we (including Affiliates) collect and safeguard your information as well as how we use this information to improve our products and services for the benefit of all our customers.

The personal information you choose to share with us, along with data collected on how you use our Websites help us to better understand our customers as a group and as individuals. This then helps us to advise you on the products and services that meet your needs.

### What information do we collect and how do we use it?

We will at all times only collect and process your personal information in accordance with the General Data Protection Regulation 2018, the Privacy and Electronic Communications (EC Directive) Regulations 2015 as amended, and any other applicable data protection legislation including the following;

- information about your computer and about your visits to and use of our Websites (including your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views and Website navigation paths);
- searches completed and preferences selected when using any of our Websites linked to this policy;

- information that you provide to us when registering with any of our Websites (including your name and email);
- information that you provide to us for the purpose of subscribing to our email notifications and/or newsletters (including your name and email);
- information that you provide when completing your profile on any of our Websites (including your name, email, telephone, mobile and date of birth);
- information relating to any purchases you make of our goods or any other transactions that you enter into through any of our Websites (including your name, email, address, phone number);
- information that you provide when you take part in promotions, prize draws, competitions, customer surveys and questionnaires;
- information that you give us when you contact us in writing or by phone; and
- any other personal information that you choose to send to us.

Finally, we may receive information about you from third parties who are legally entitled to disclose that information.

#### Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our Site. #### Web browser cookies

Our Site may use "cookies" to enhance User experience. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. #### Information collected

#### ***STRICTLY NECESSARY COOKIES***

These cookies perform important functions on our Websites. Without them we cannot provide you with basic features and normal website behaviour which you will expect from us. For this reason, you cannot disable these cookies.

#### ***FUNCTIONAL COOKIES***

These cookies allow our Websites to remember choices you make and provide enhanced, more personal features. They may also be used to provide services or functionality you indicate you are interested in through interactions with our Websites. These cookies are only used to provide an

improved browsing experience and we do not pass information about the choices you make to any third party or other organisation.

#### *PERFORMANCE COOKIES*

These cookies collect general information about how visitors use our Websites to help us improve our Websites for everyone. For instance, we track which pages visitors go to most often and if they get error messages or broken links. These cookies do not collect personal information that identifies a visitor. All the information these cookies collect is aggregated and therefore anonymous.

We may make use of analytics tools from Google or Bing for this purpose.

#### **How we use collected information**

We may collect and use Users personal information for the following purposes:

##### **To improve customer service**

Information you provide helps us respond to your customer service requests and support needs more efficiently.

##### **To send periodic emails**

#### **Is my information shared with anyone else?**

We do not sell, trade, or rent Users personal identification information to others. ## What are my rights?
